

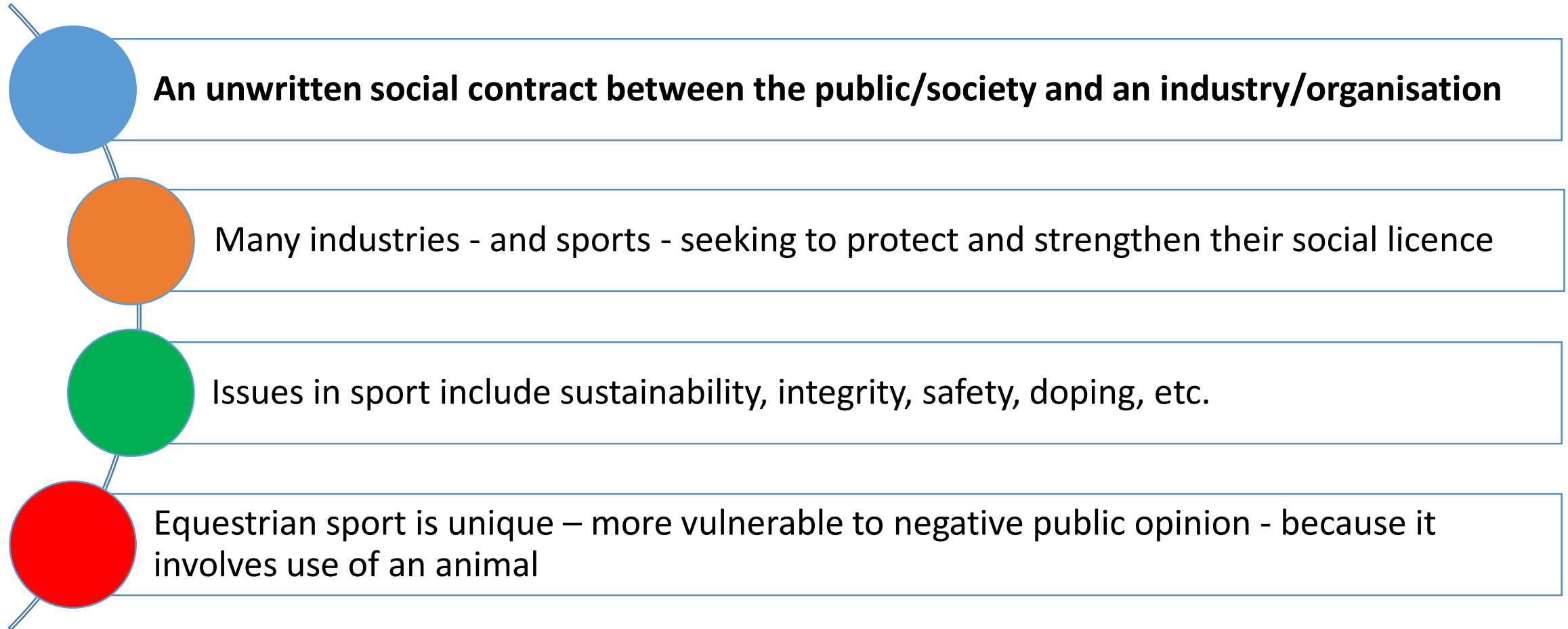

Why now? – rising public concerns

- All equestrian sports increasingly coming under the spotlight
- Society does not distinguish between different equestrian sports
- Society does not recognise a difference between FEI and non-FEI regulated sports
- In some cases the public don't distinguish between species (all animals used in sport or entertainment)
- *The Public may prioritise emotion over evidence in deciding to grant social licence or not.*

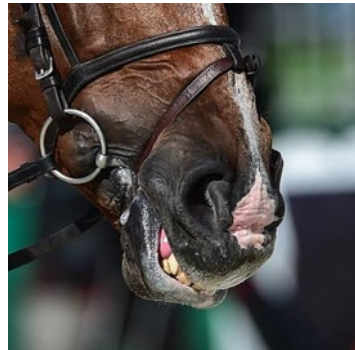

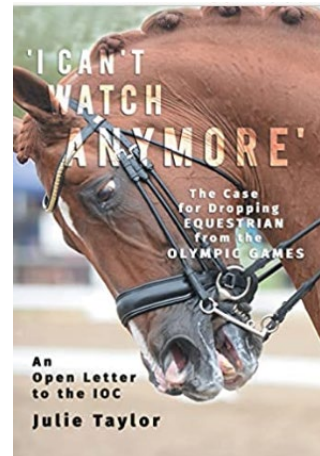
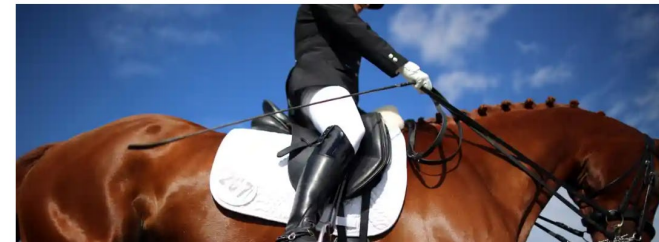

Abstract

The concept of ‘social licence to operate’ (SLO) is relevant to all animal-use activities. An SLO is an intangible, implicit agreement between the public and an industry/group. Its existence allows that industry/group to pursue its activities with minimal formalised restrictions because such activities have widespread societal approval. In contrast, the imposition of legal restrictions-or even an outright ban-reflect qualified or lack of public support for an activity. This review discusses current threats to equestrianism’s SLO and suggests actions that those across the equine sector need to take to justify the continuation of the SLO. The most important of these is earning the trust of all stakeholders, including the public. Trust requires transparency of operations, establishment and communication of

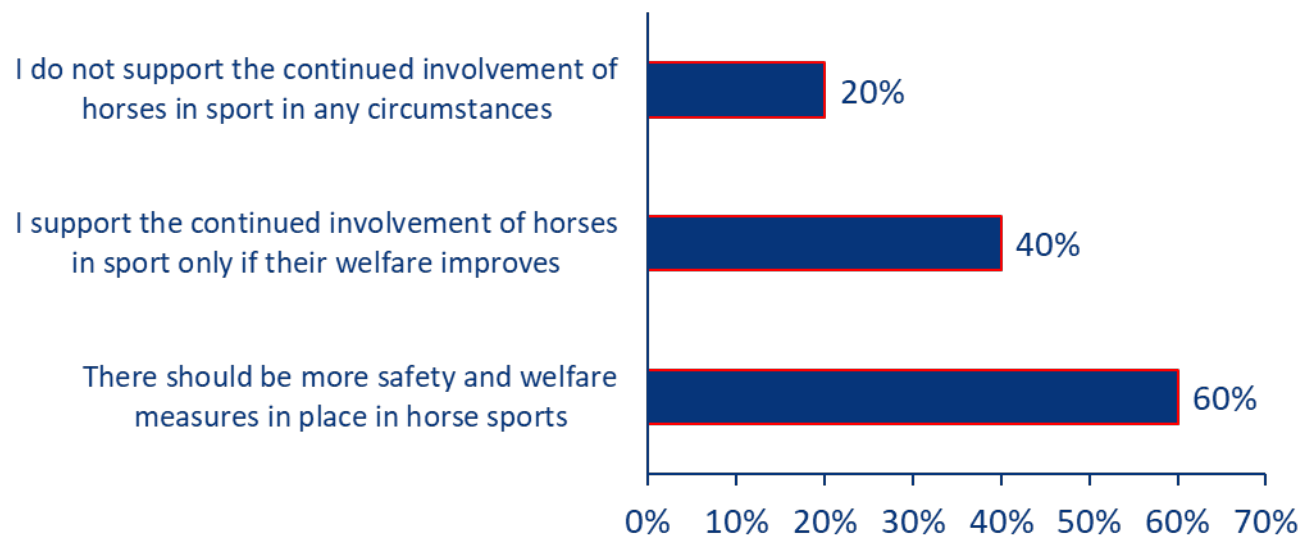

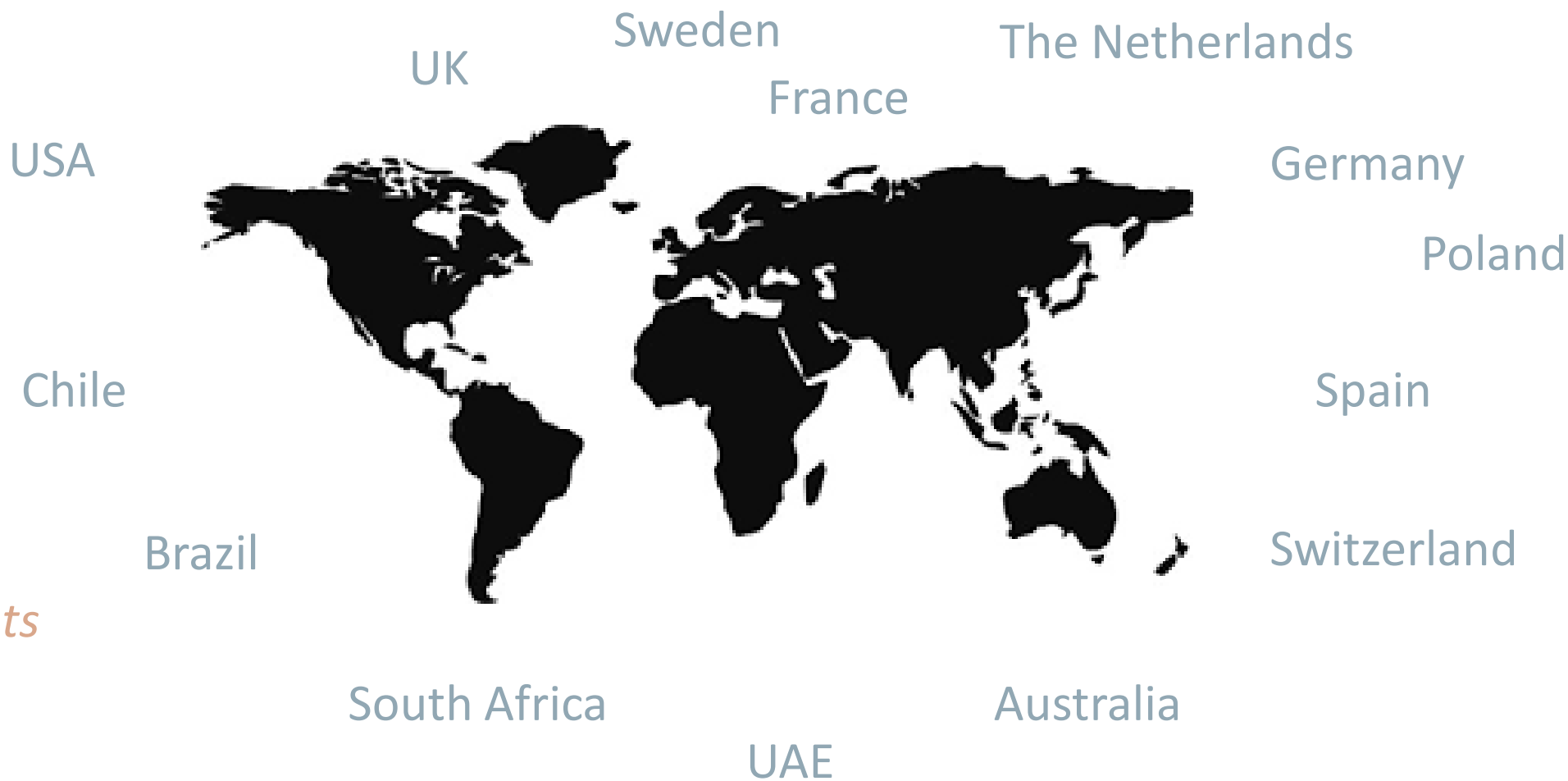

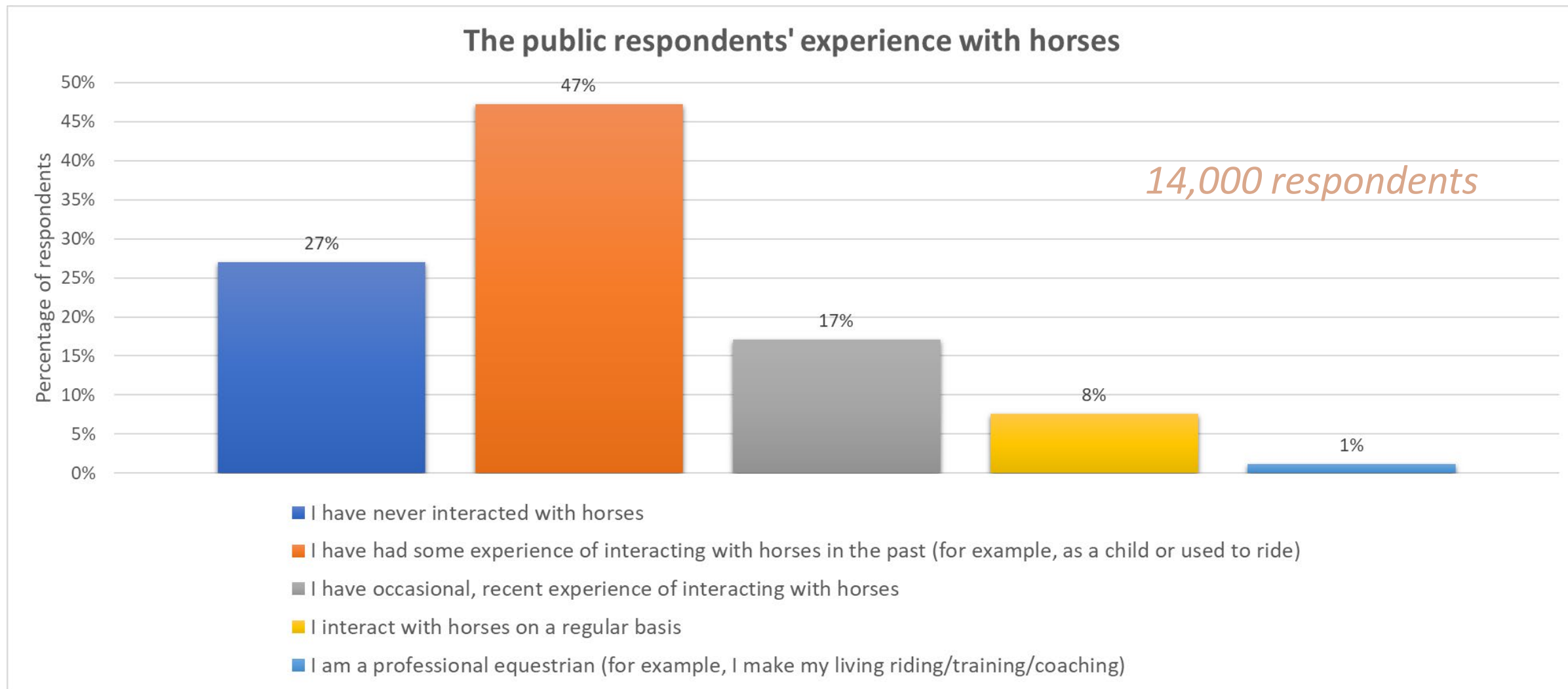
Public Survey: The Public respondents – *where do they reside?*

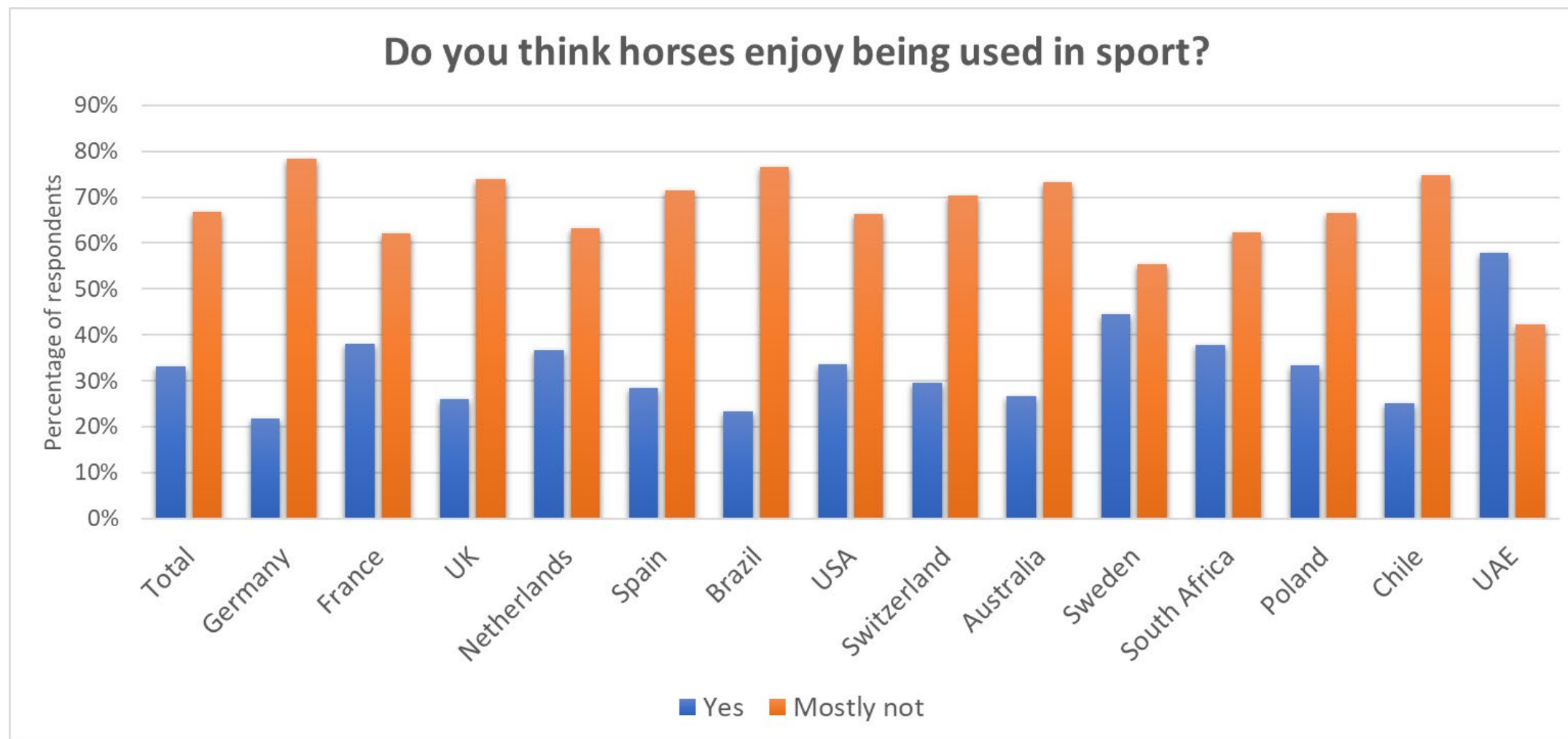

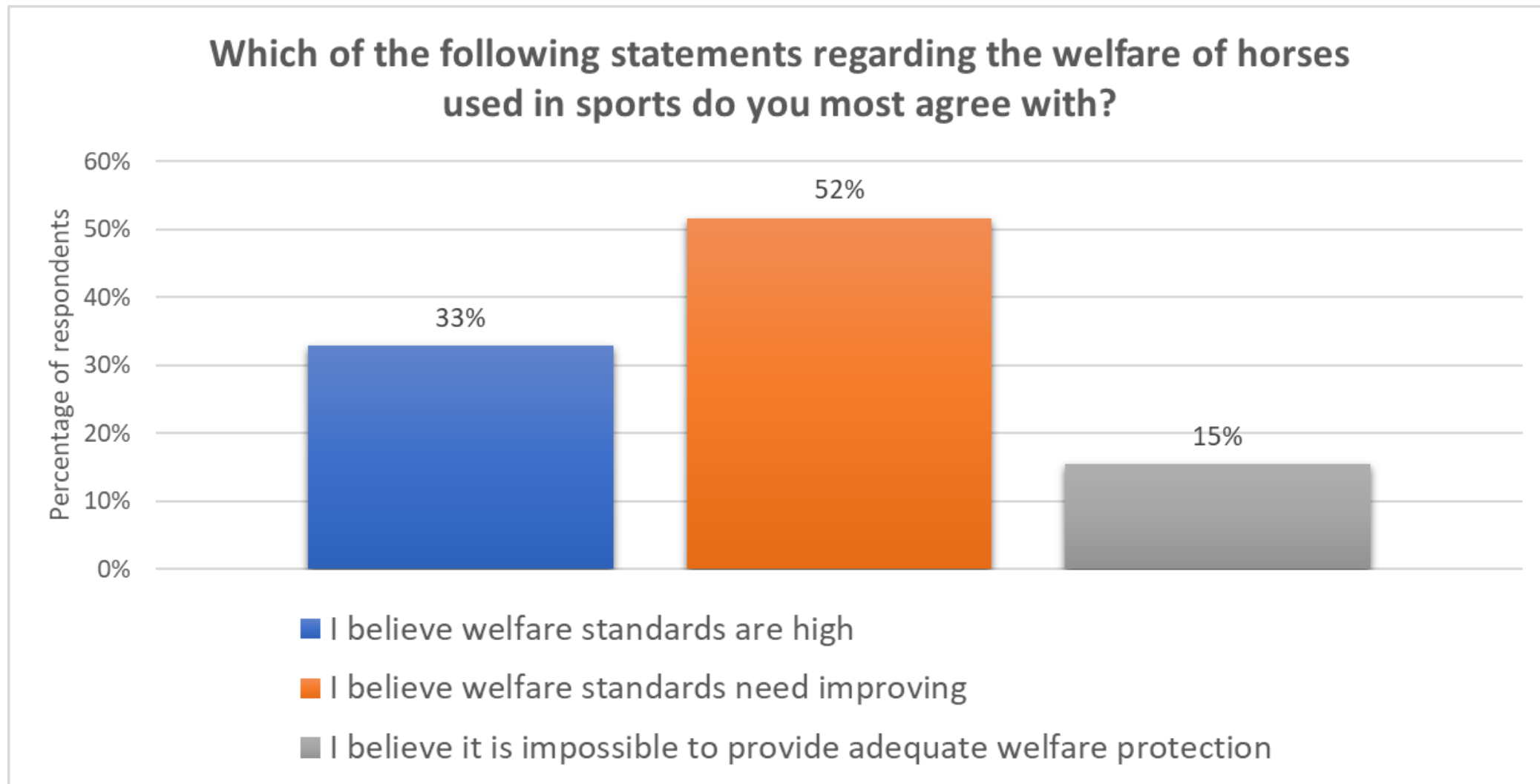
Is the Iceberg melting? – public perception

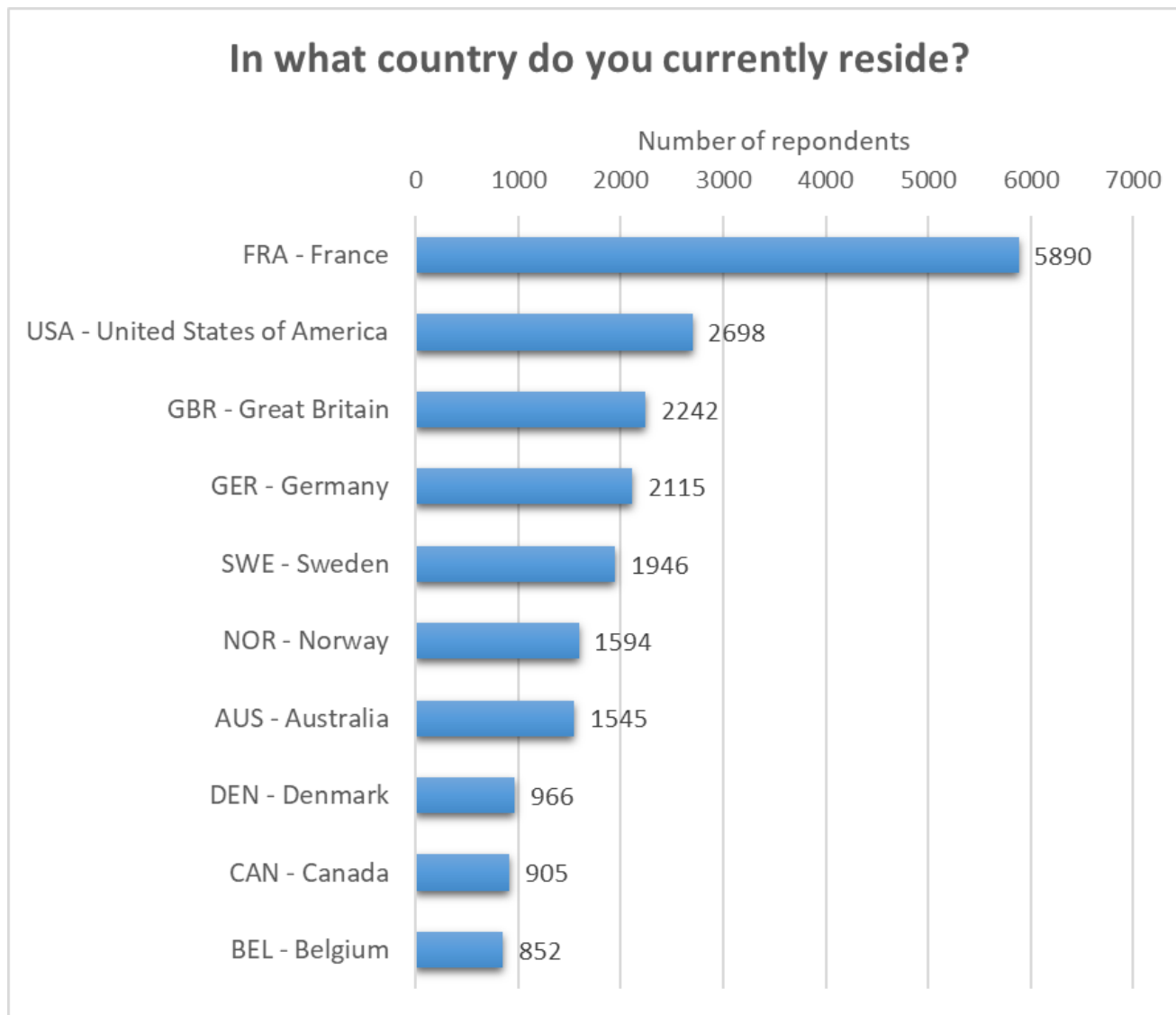

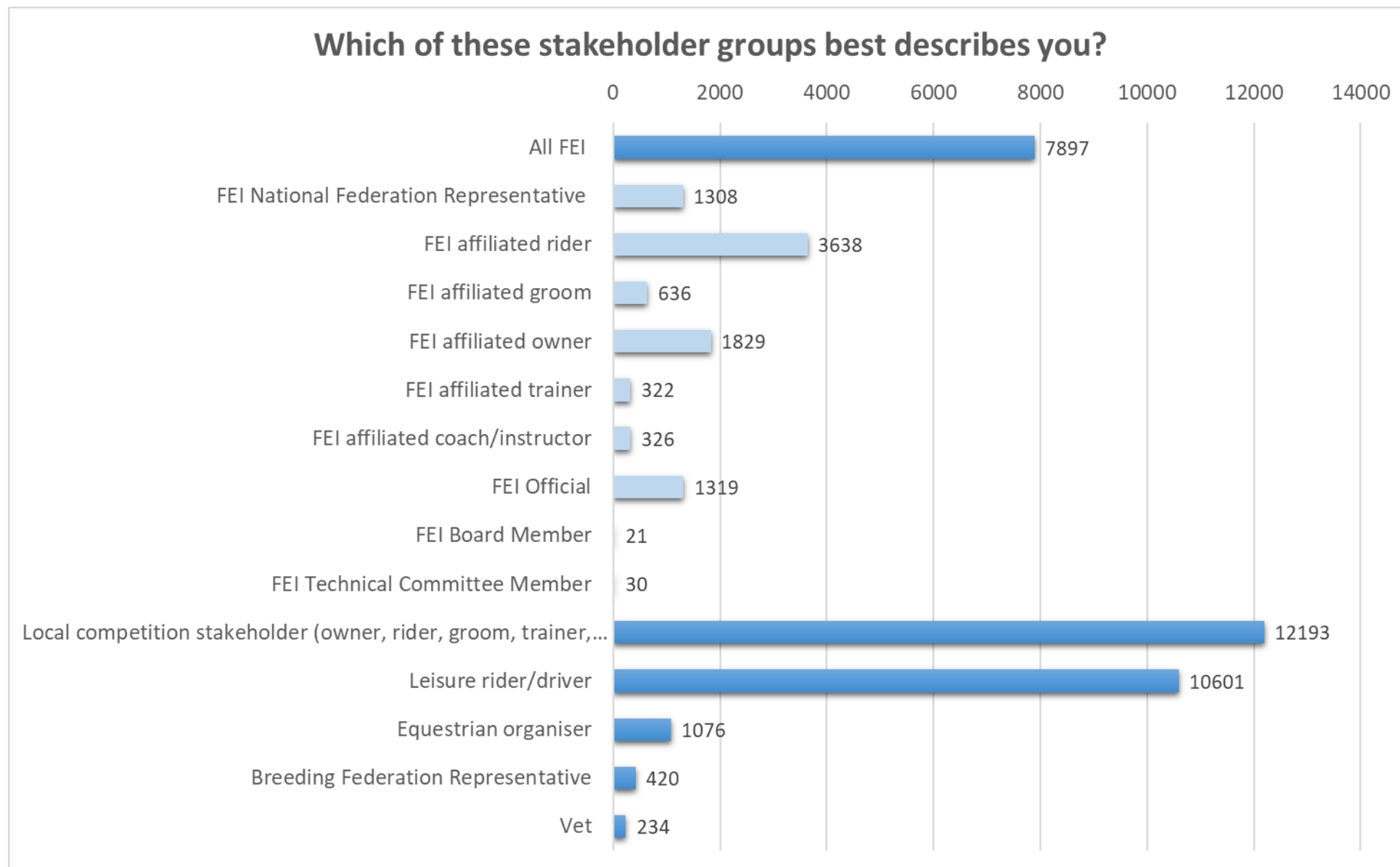

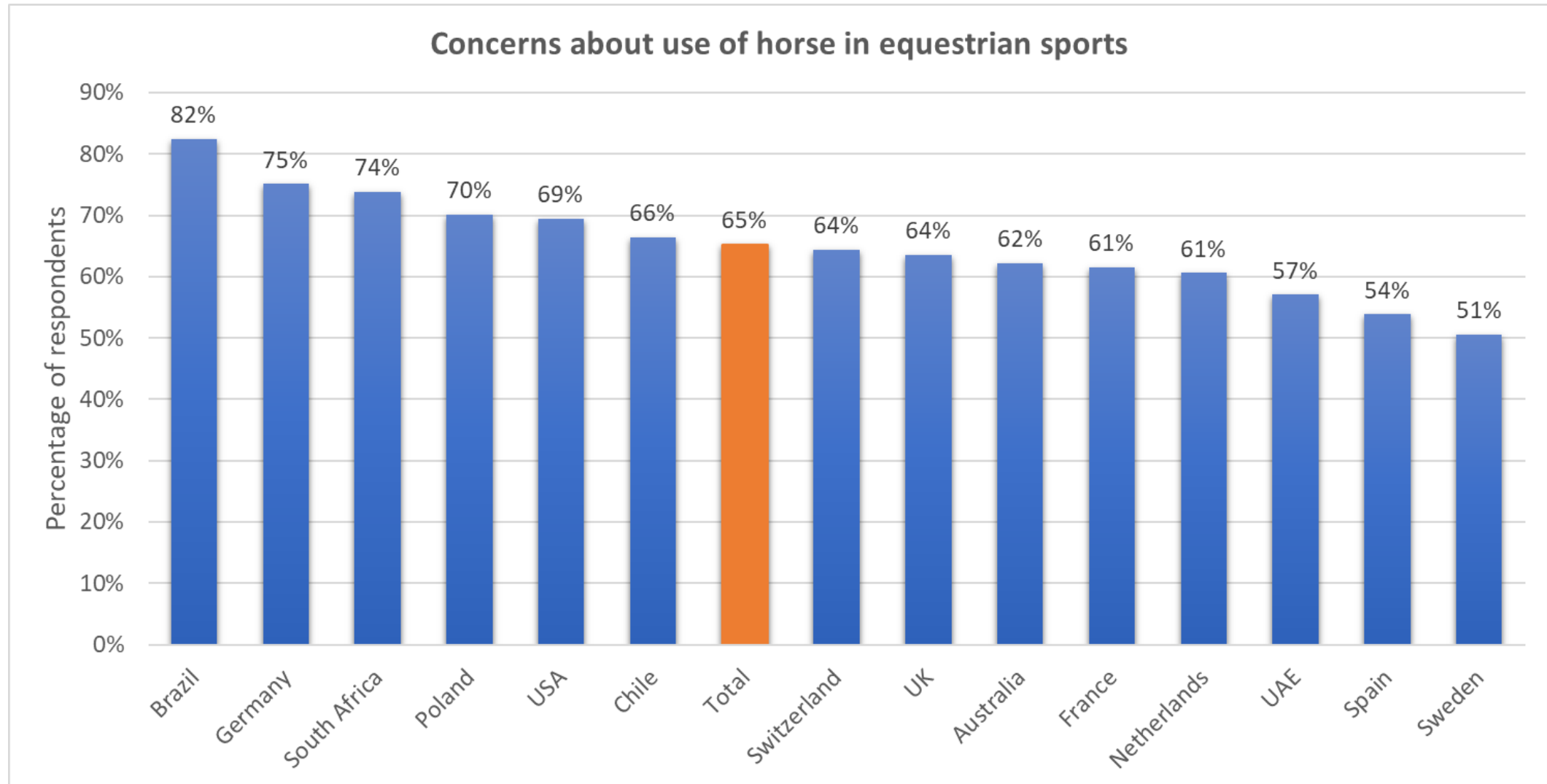

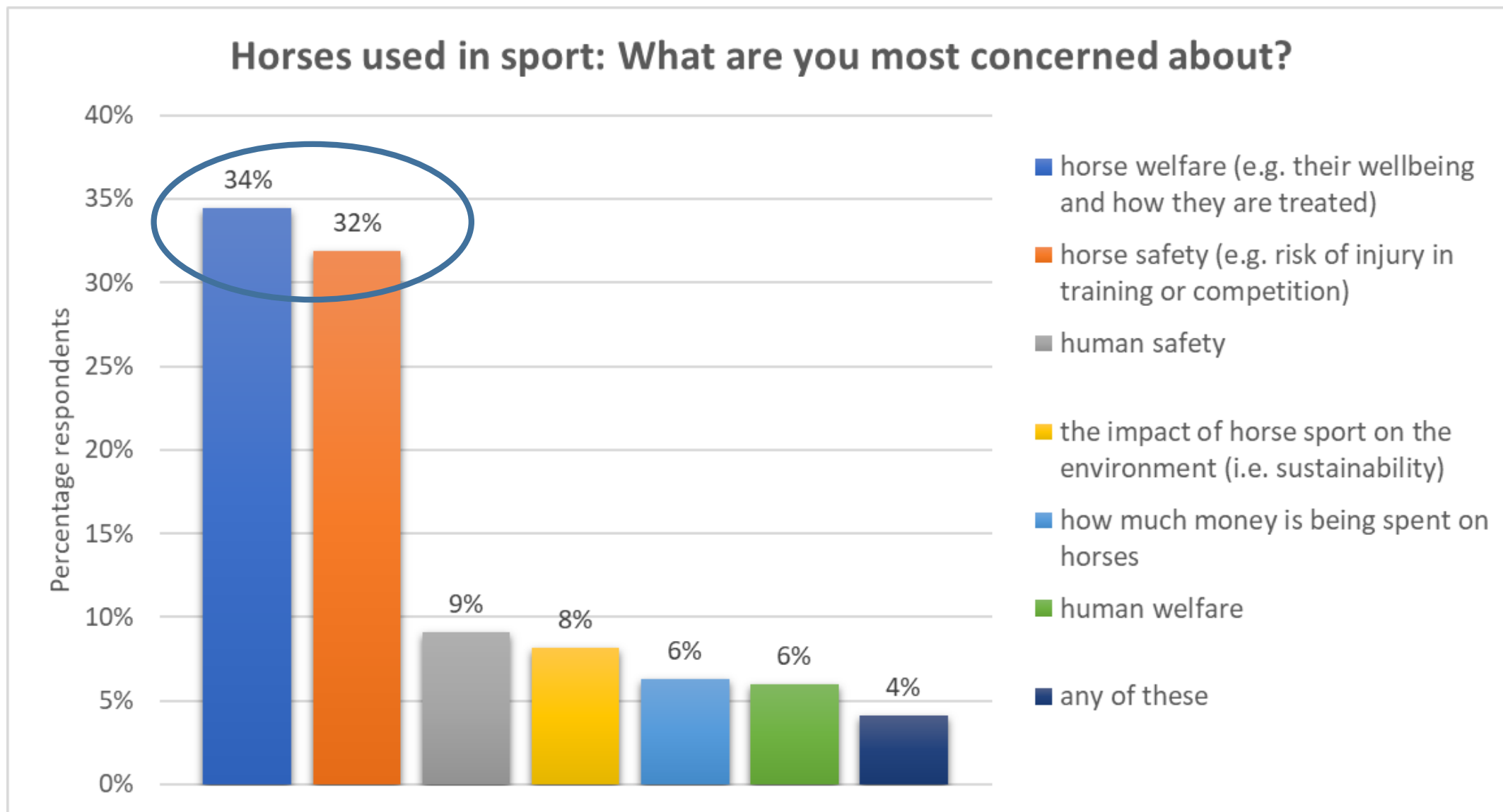

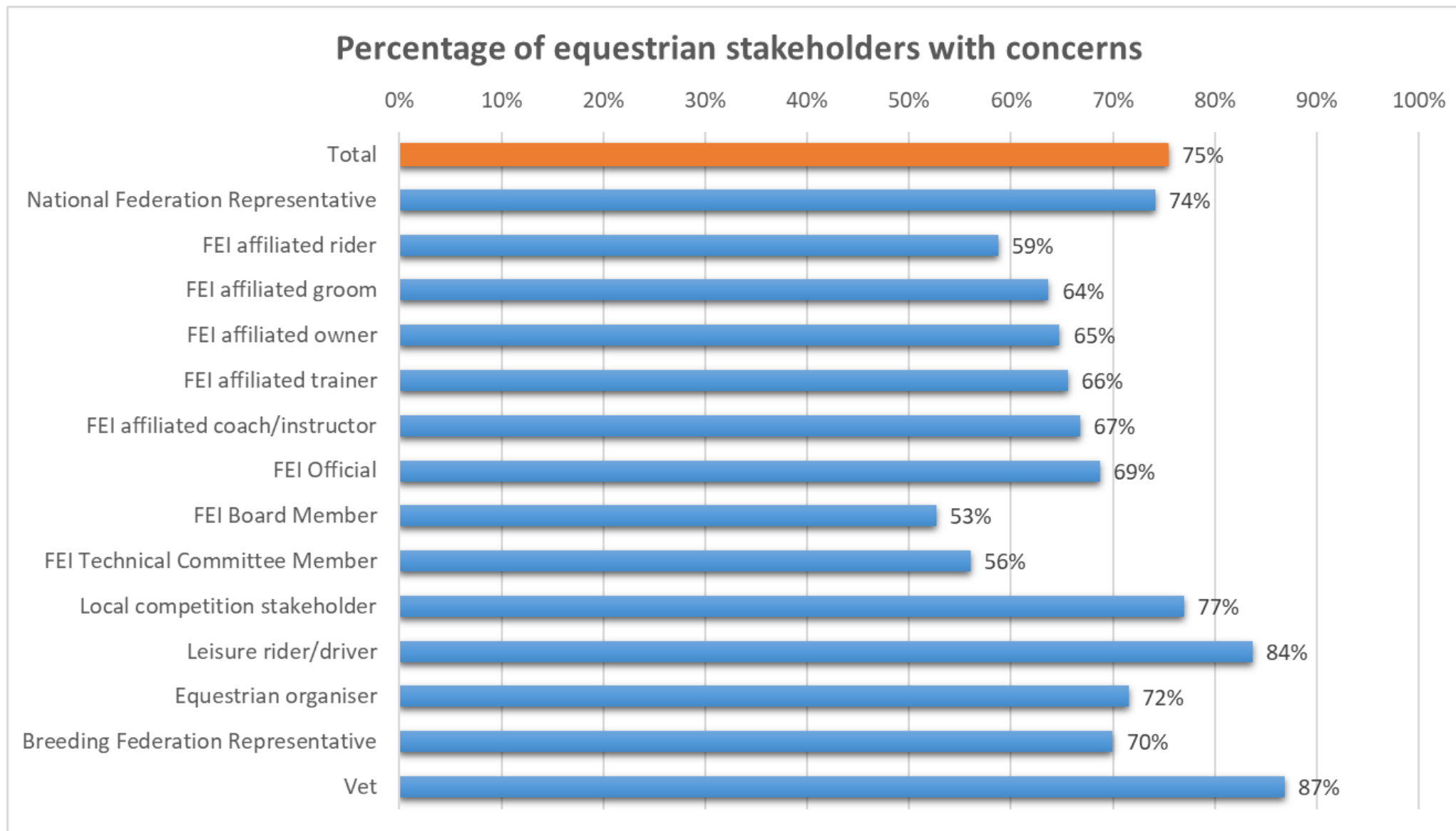


What were the main Concerns of the public ?



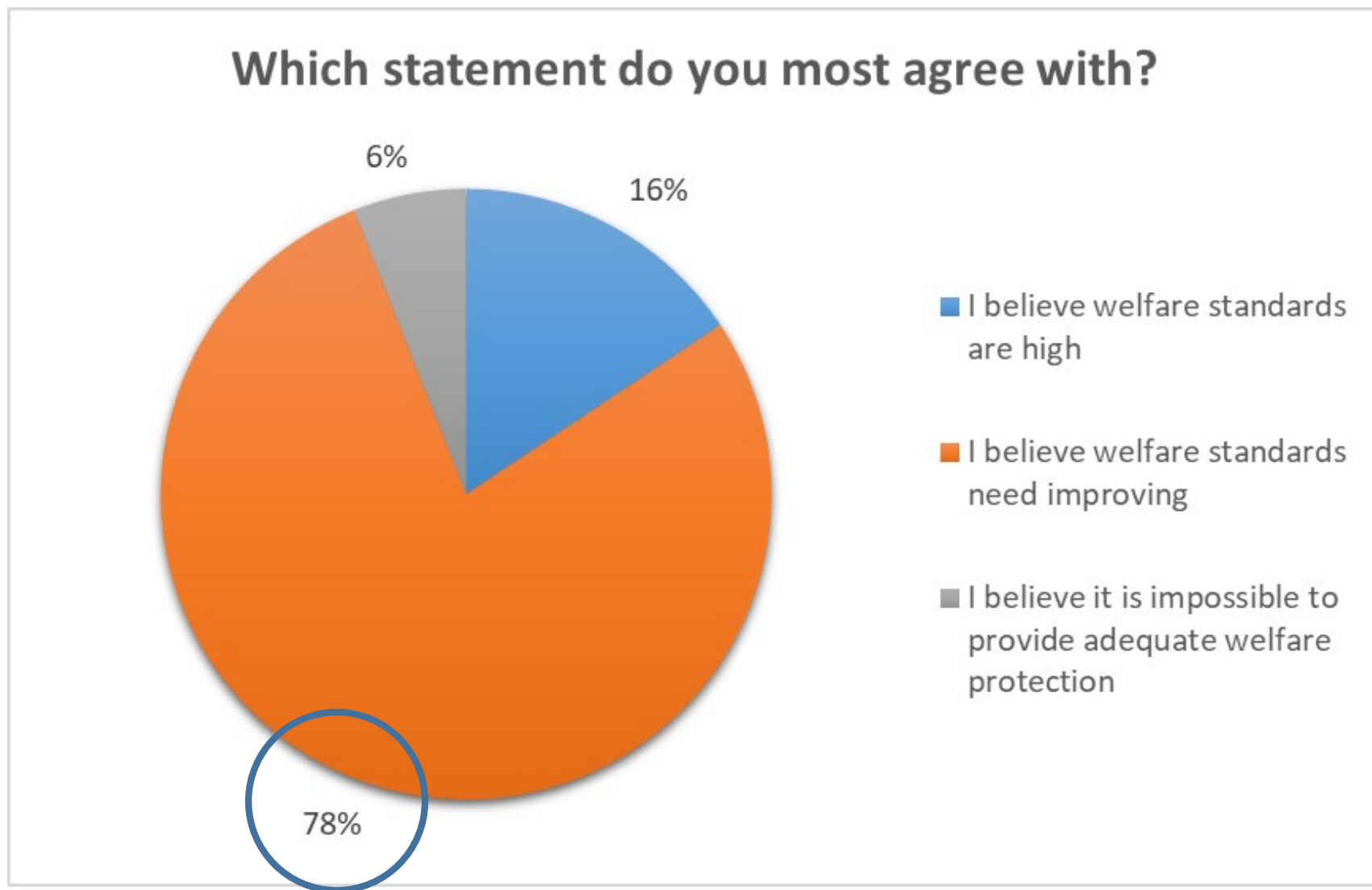

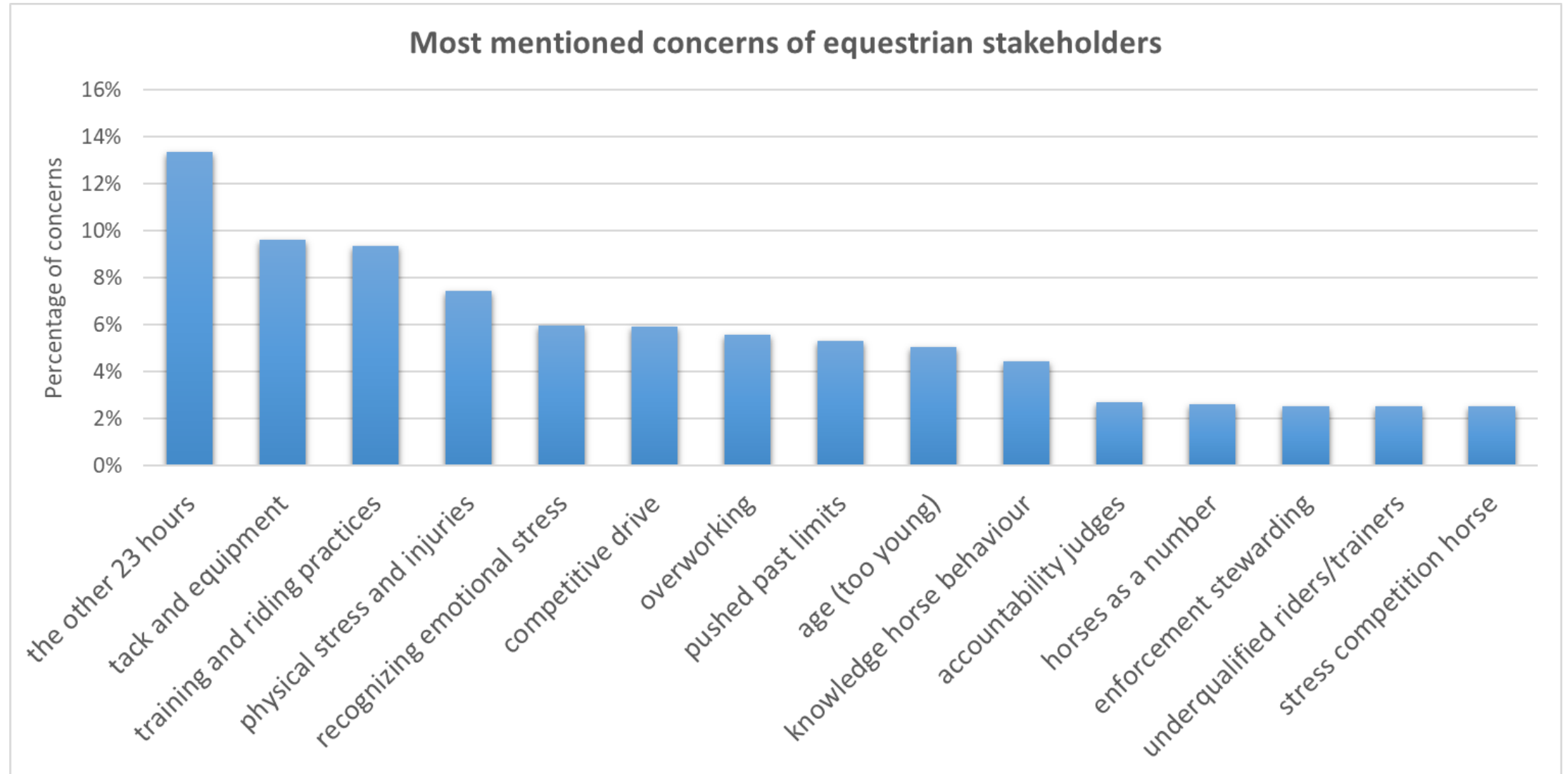

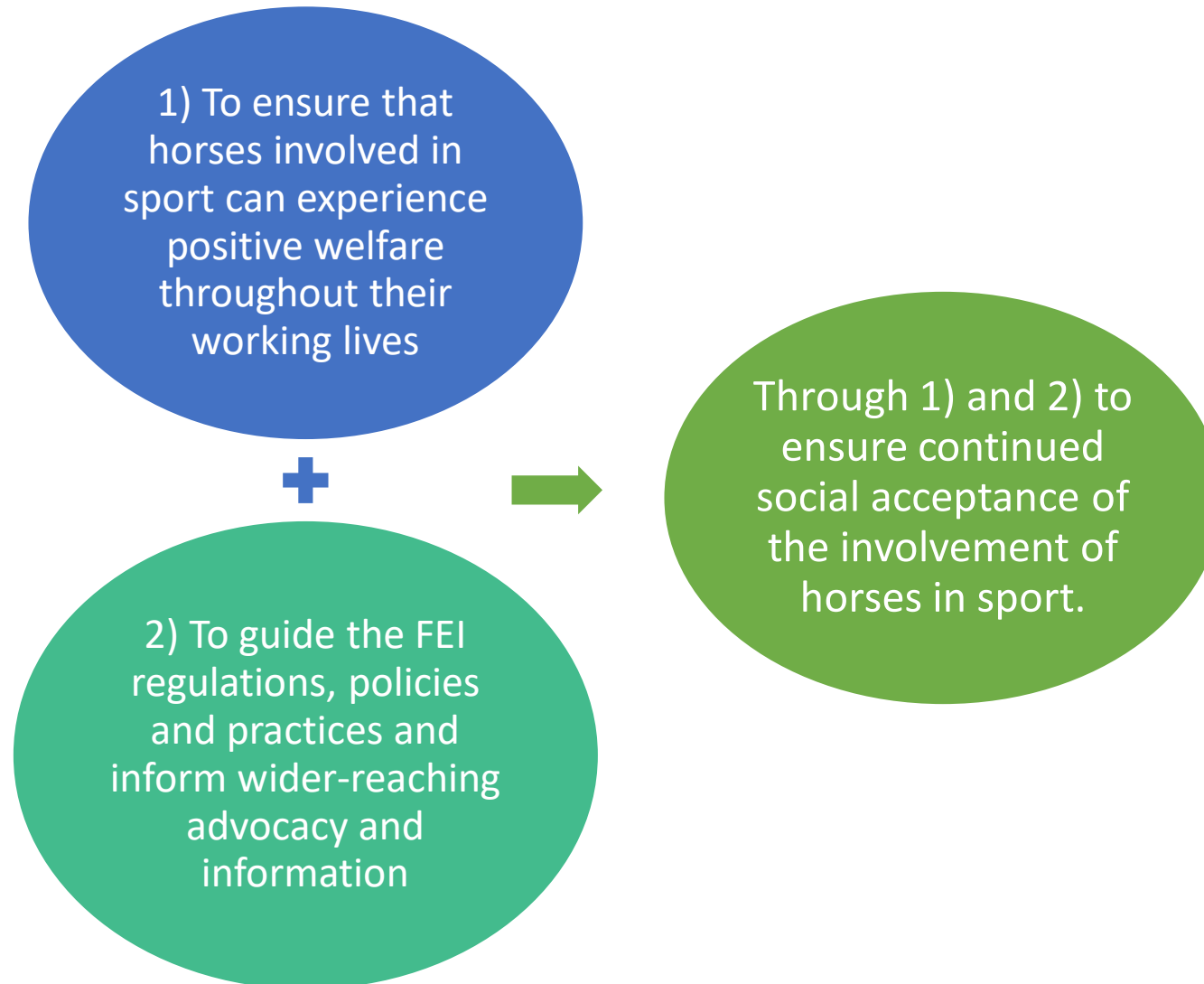

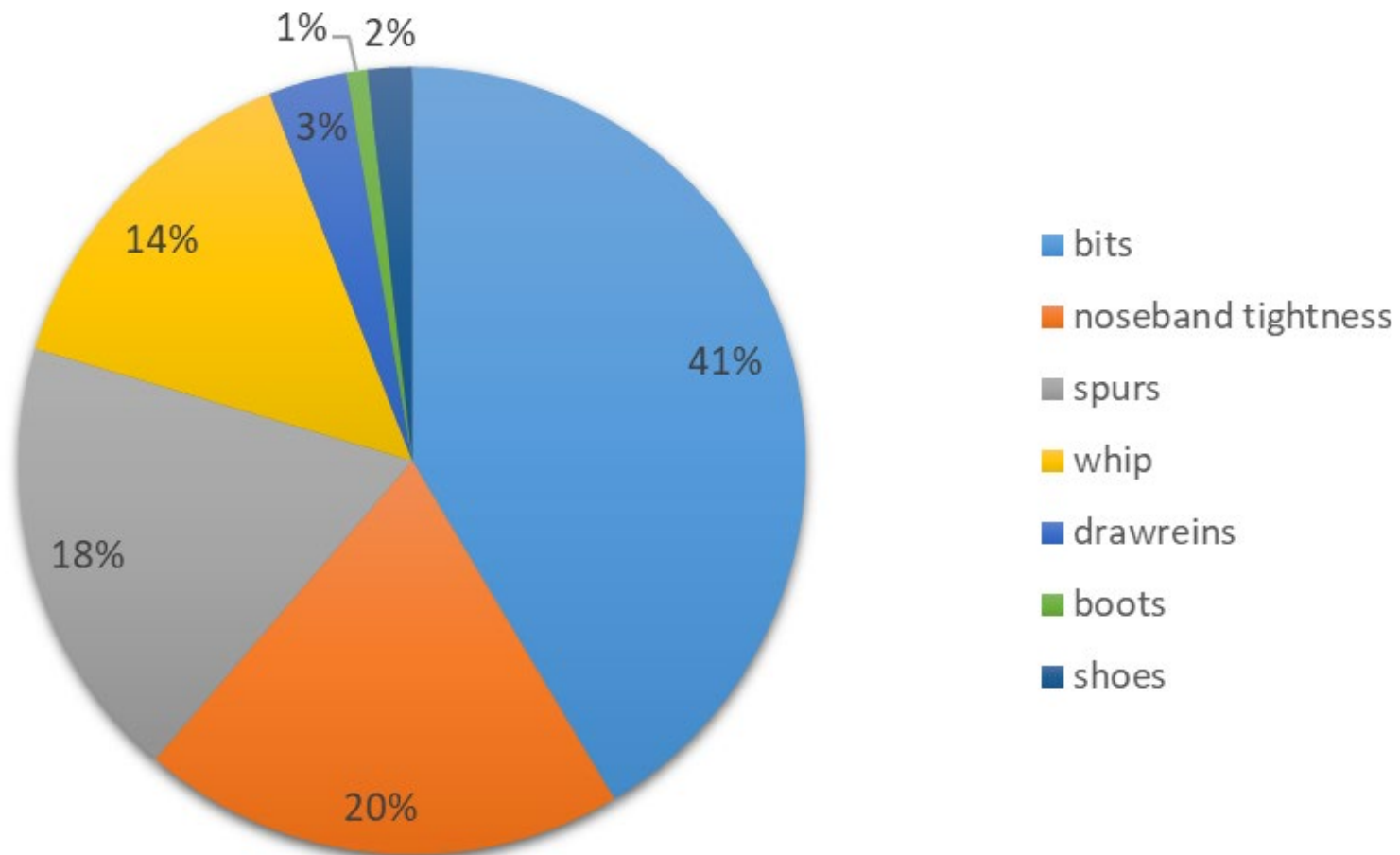
Basis for Commission Recommendations

- ✓ **Public and Equestrian Survey Results**
- ✓ **External related information** – External reports, information from animal welfare organisations, independent survey results
- ✓ **Research evidence** - Reviewing research publications related to equine wellbeing and ethics. Identifying gaps in knowledge, making recommendations for where research is needed.
- ✓ **Consultation with Equine Stakeholder and Equine welfare experts (FEI and non-FEI)** –consultation regarding specific concerns and potential solutions with different groups involved with equine welfare and use of horse in sport
- ✓ **EEWB Advisory/Working Groups** –Scientific Advisory Grp, Education Working Grp, Legal Working Grp, Communication Working Grp.



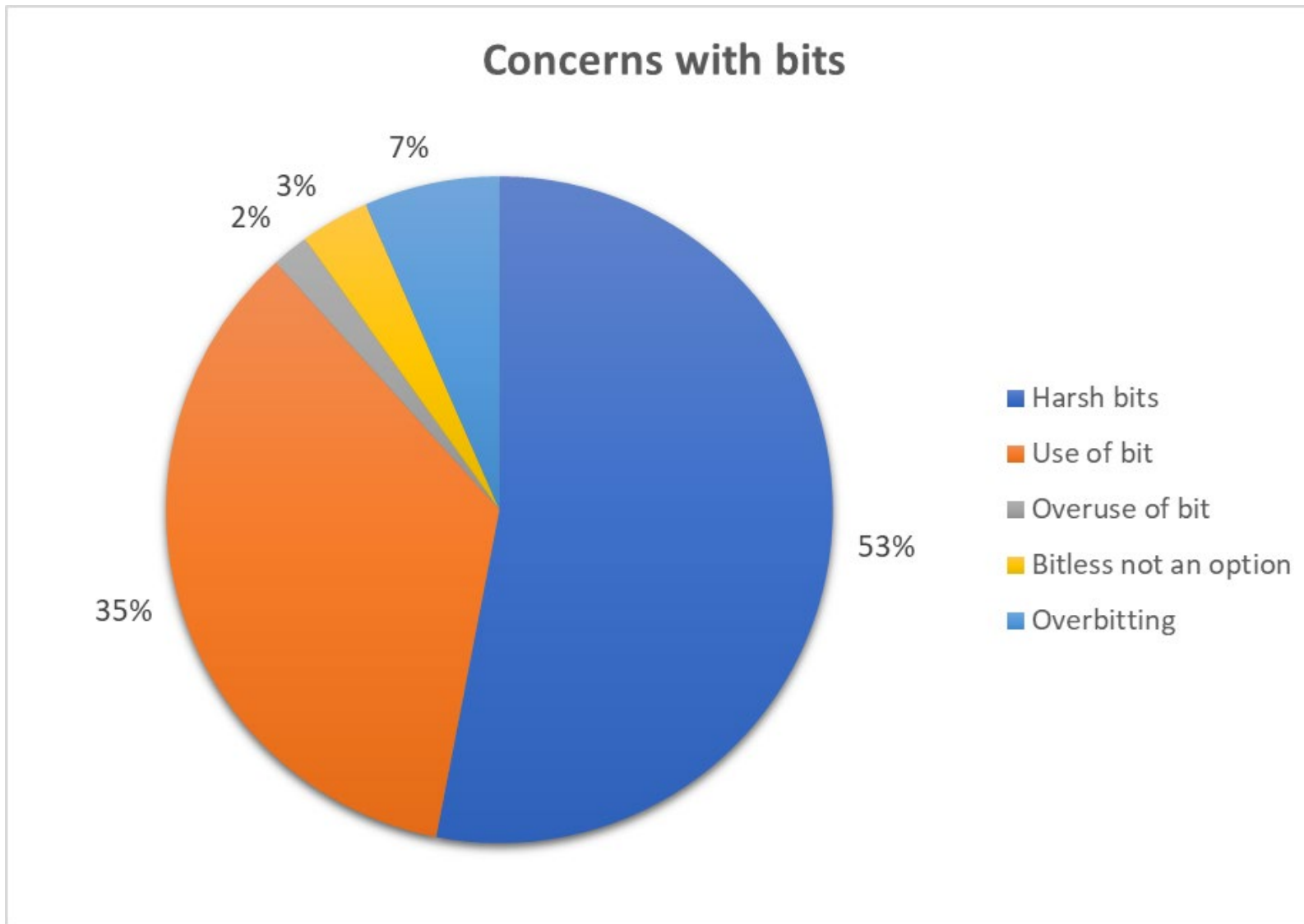

Recommendation 1

Tack and Equipment – Double Bridles

Double bridles should not be mandatory and should be made optional in FEI Grand Prix Dressage. Currently the use of double bridles is mandated by FEI regulations for dressage when horse and rider achieve a specific level of competition (FEI, 2022). The Commission recommends that double bridles should not be mandatory at any level of dressage, and the regulations changed so that use is optional for riders competing at Grand Prix level.

1.Supporting information

- Although bits can be extremely effective and especially when used with great care, bits and especially more severe bits are a risk in that they can cause extensive damage to the tongue, bar and hard palate of a horse's mouth (Cook 1999, Mellor 2021)
- It is already the case that double bridles are optional for riders competing under a number of National Federation regulations at Grand Prix level
- Use of more severe bits designed with stronger deceleration pressures used in conjunction with accelerator devices such as spurs are a welfare risk (Hill et al., 2015; Condon et al., 2022)
 - Increased chance for misuse through overshadowing of "go" and "stop" responses (Condon et al., 2022)
 - Increased conflict behaviours (Condon et al., 2022)
 - The use of a double biting system for the horse has the potential to interfere with coherence of the cues/aids (Cross et al., 2017)
 - Repeated mouth opening (used as an indicator of discomfort or pain) was seen in more than 50% of horses competing in Grand Prix level Dressage (Dyson et al 2021)
 - Double bridle noseband design most commonly involves crank nosebands, which have been linked to additional welfare concerns due to the ease in which they can be overtightened (McGreevy et al., 2012)
 - Double bits including lever action increase the risk of a horse experiencing pain/fear and conflict. Addition of a curb bit which makes use of levers that amplify rein tension, with the shank

Commission members present: Kathalijne, Madeline and Nat

Summary of meeting:

Facilitated by Dr Orla Doherty, and equine veterinarian with a special interest in equitation science and equine welfare – the meeting took place via Zoom, with 4 equine veterinarians and one surgeon.

Main points are as follows:

1. There is not a lot of space in the horse's mouth
2. It is impossible to have a bit in the mouth and have no pressure
3. The mouth has many sensitive areas

Early Recommendations to the FEI Board

Recommendation 1

Tack and Equipment – Double Bridles

Double Bridles should not be mandatory and should be made optional in FEI Grand Prix Dressage

Other Early Recommendations

Tack and Equipment – 3 recommendations

- **Double bridles** should not be mandatory
- **Spurs** should not be mandatory
- **Nosebands** should not be tight – A uniform method of measurement including an agreed definition of ‘too tight’, should be used based on the available science.

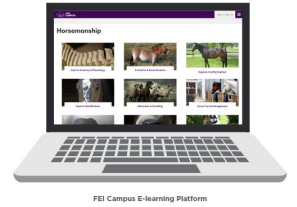
Regulation – 1 recommendation

- Include in the FEI General Regulations a rule to apply consistently to all Disciplines to allow elimination on horse welfare grounds

Others – 2 recommendations

- Establish an Education Focus Group to review existing modules in FEI Campus and propose new ones
- Establish a Research Fund to address gaps in current knowledge regarding Equine Welfare

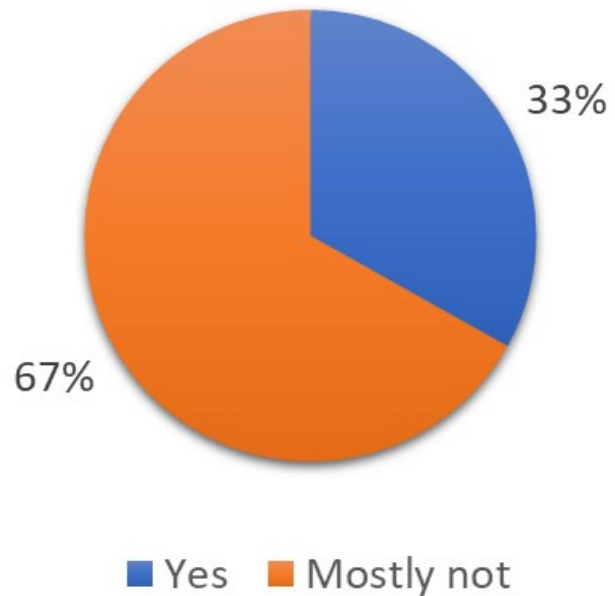

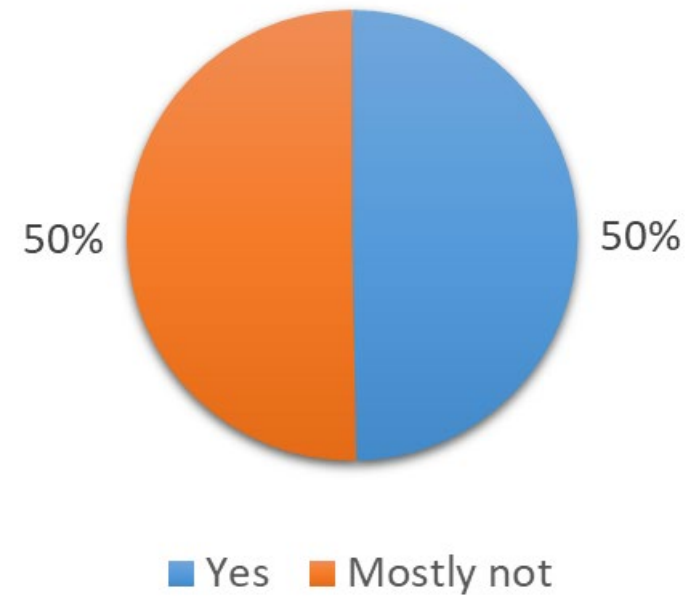

Public: Do you believe horses enjoy being used in sport?

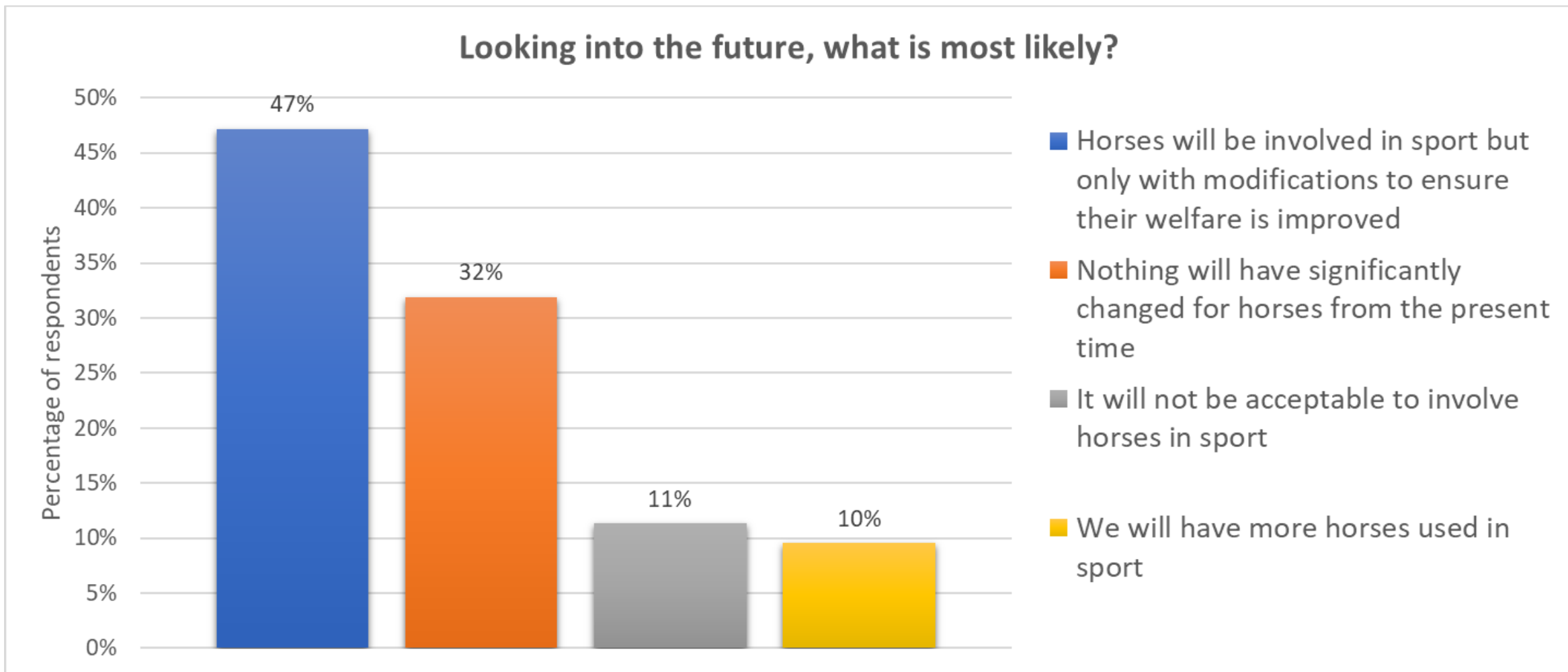


Equestrians: Do you believe horses enjoy being used in sport?



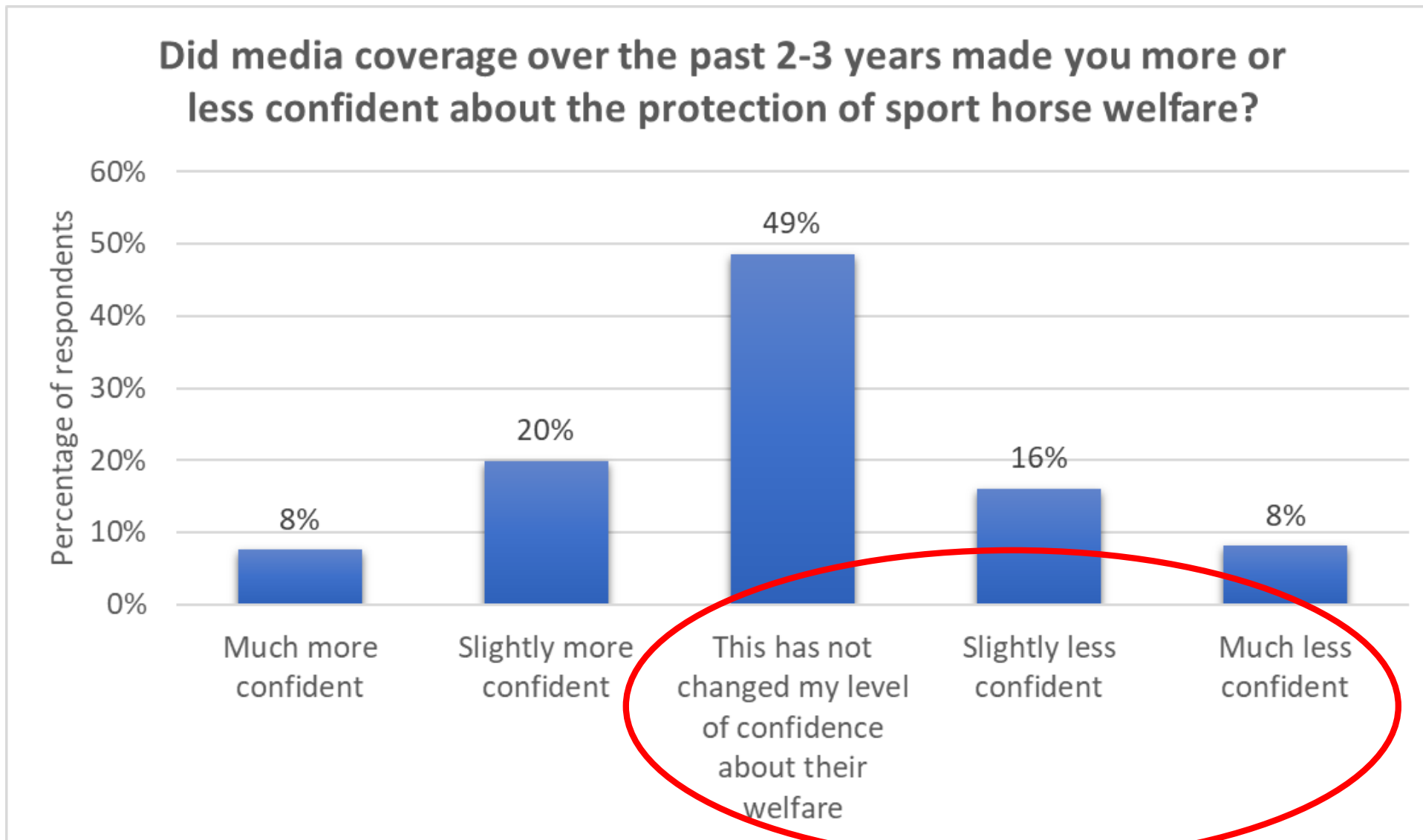


How do the public feel about the future of the involvement of horses in sport?



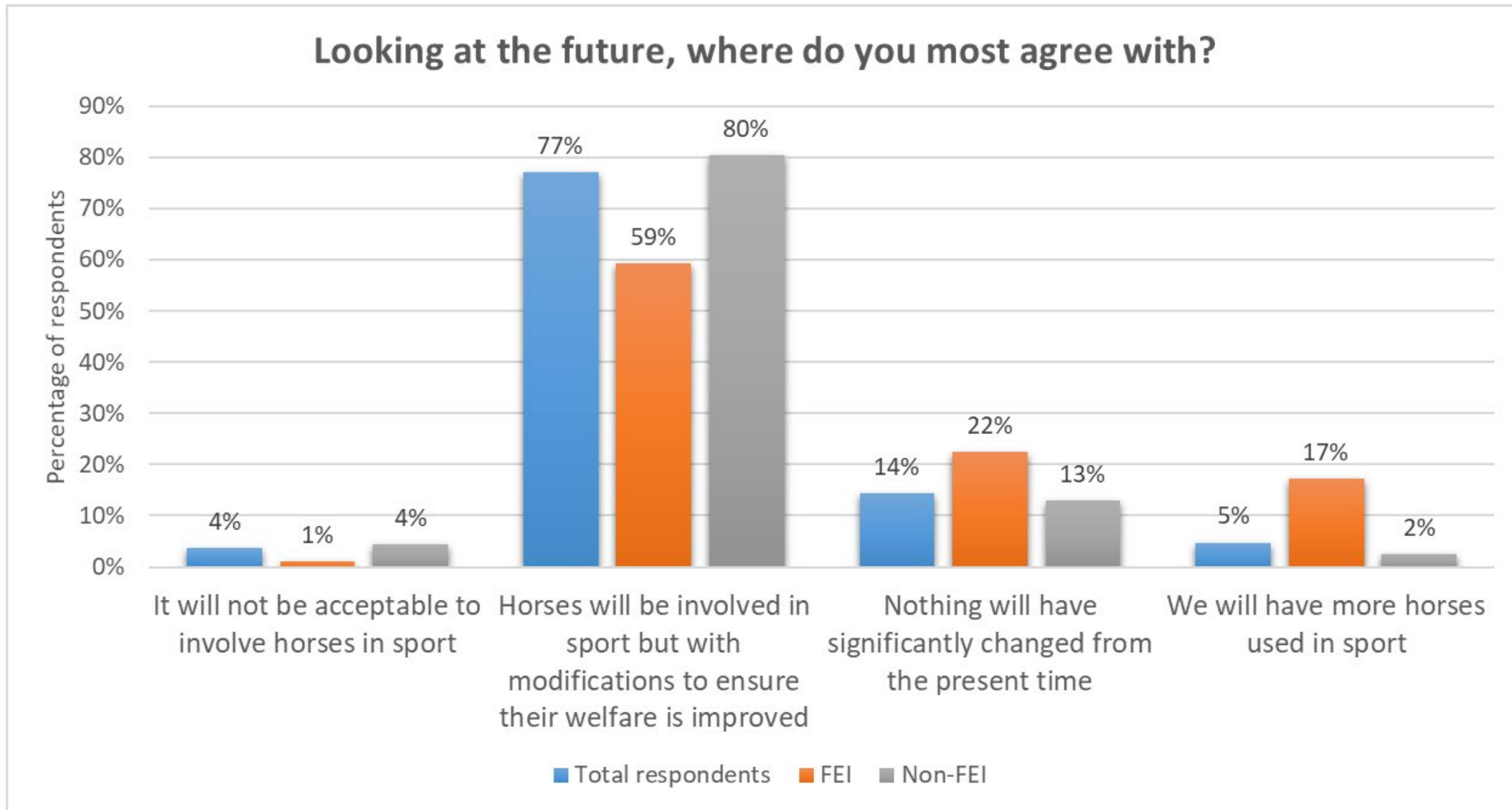


Impact of media coverage on Public



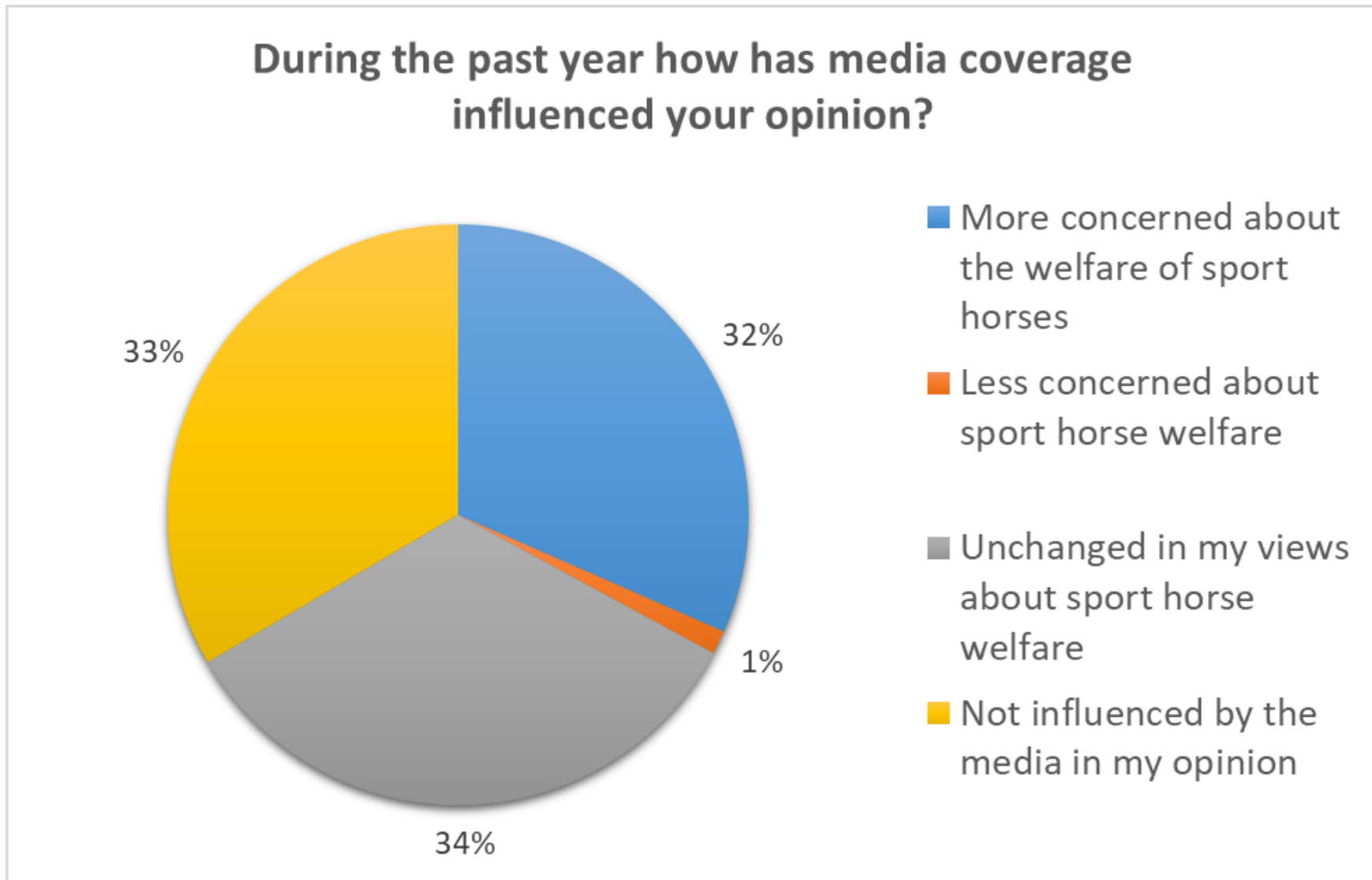
